

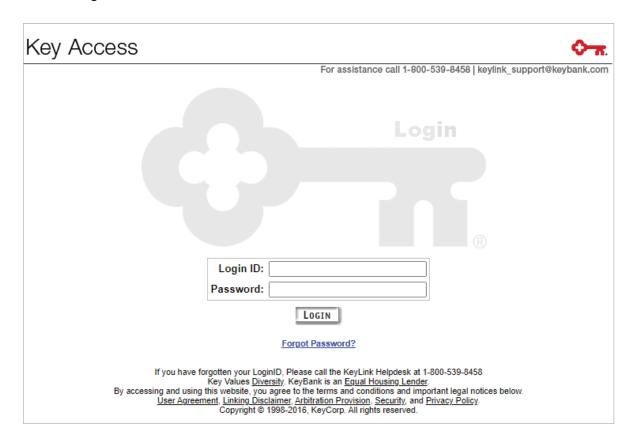

# PayeeWeb New User Guide — Using the Pensioner Portal

This quick-reference guide is designed to walk you through setting up your pensioner account in KeyBank's PayeeWeb pensioner portal. You should have received a mailed Login ID letter from KeyBank, followed by a Password letter, and gone through the initial login process.

## Visit key.com/payeeweb. Log in to the portal.

1. Now that you have gone through the initial login process, enter your login ID and your password. Click the Login button.



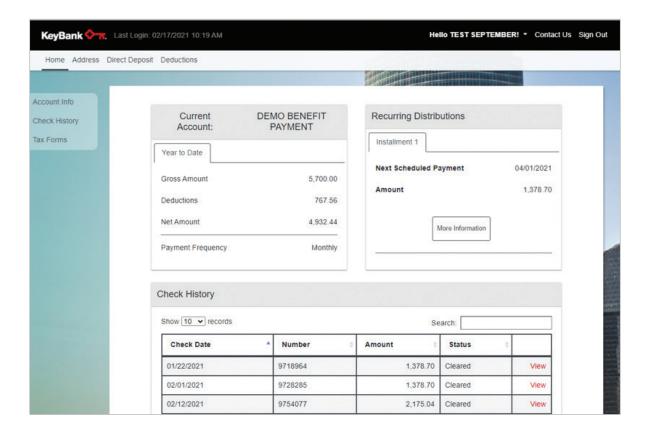

## Navigate the main portal dashboard to locate the information you need.

- 2. This includes:
  - Account Info Year-to-date gross amounts, net amounts, and deductions.
  - Check History A user-friendly check history record showing payment you have received.
  - Tax Forms Access current and previous years' tax forms.

You can also navigate to view your:

- Address (and update if authorized by your plan sponsor)
- Direct deposit information (and update if authorized by your plan sponsor)
- Deductions

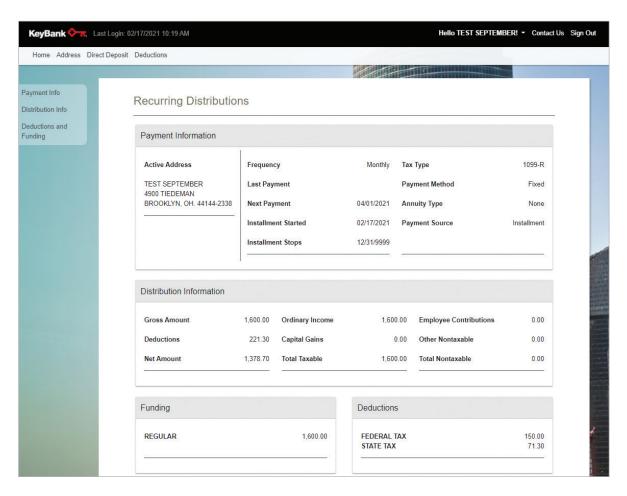

## Recurring Distributions > More Information

- 3. Accesses more detailed information related to your pension/retirement installment payments, including:
  - Active Payment address
  - Frequency of the payments
  - Last Payment and Next Payment
  - When installments started and when they stop
  - Detailed distribution information such as gross income, taxable income, and more.



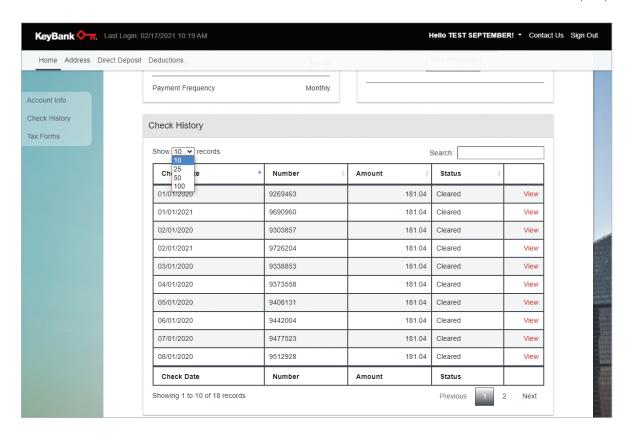

## **Check History**

4. Shows a view of all checks or EFTs since you started to receive benefits from your pension plan.

Select the View link to see additional details about an individual check or Electronic Funds Transfer (EFT).





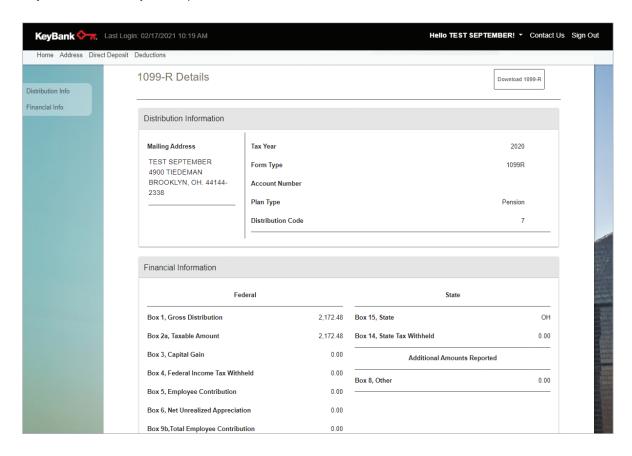

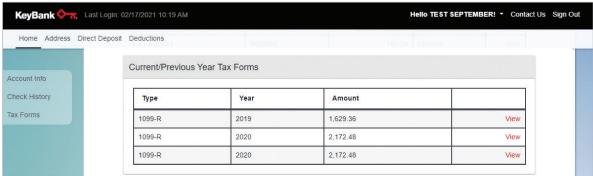
#### Tax Forms

5. Shows a view of any tax forms for the current or prior years, typically 1099-R forms. Select the **View** link to open the tax form details screen.

The 1099-R Details screen shows distribution information and financial details, listing individual tax box information, allowing for easy and simple filing.

The **Download 1099-R** button in the upper right corner of the 1099-R Details screen will open a copy of your tax form that you can print or save.





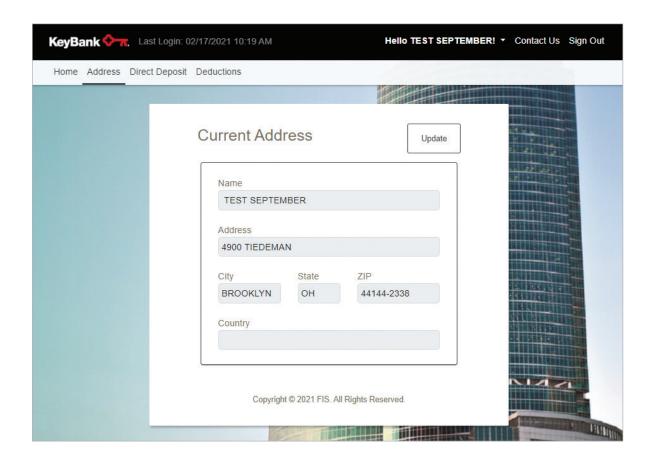

## Address

6. Click **Address** in the top navigation menu to view your current address. If your Plan Sponsor has authorized you to update your address information in PayeeWeb, you will see an **Update** button that opens the screen to enter your new address. Once you have entered your new address, click the **Update** button.

Note: If you are moving to another State, you will have to contact **KeyBank's Pensioner Information Line** directly at 1-800-962-2149.





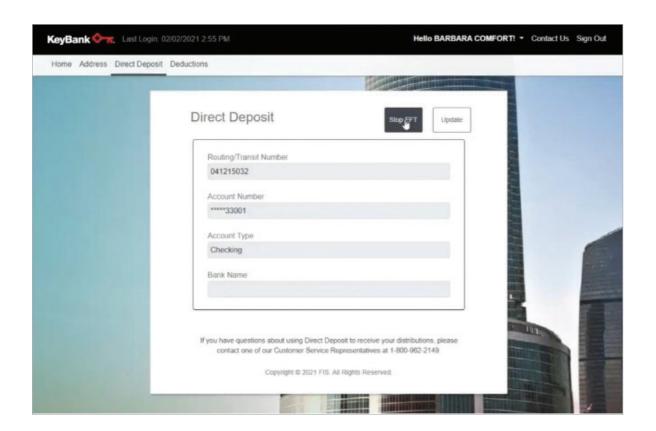

#### **Direct Deposit**

7. Click Direct Deposit in the top navigation menu to view your direct deposit information. If your Plan Sponsor has authorized you to update your direct deposit information in PayeeWeb, you will see a Stop EFT button and an Update button, which will open the screen so you can enter new direct deposit information. Once you have updated the form field information, click the Update button to update your profile.

Best practice: Double check the Routing/Transit Number field. If this field is incorrect, it could result in delayed payment.

Routing numbers are validated as part of this process. You will receive an invalid routing number notification if the number entered does not exist.



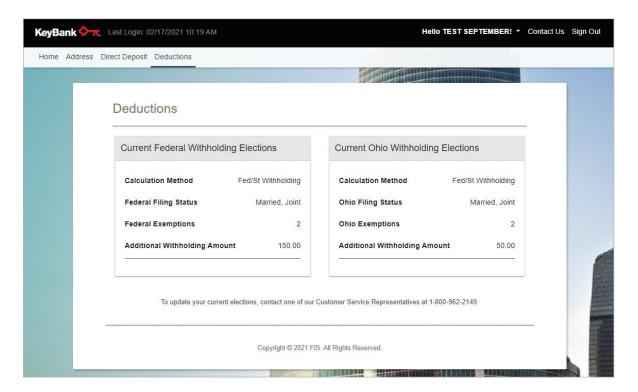

## **Deductions**

8. Click **Deductions** to access federal and state tax withholding, tax filing status, and other deductions associated with your payments.

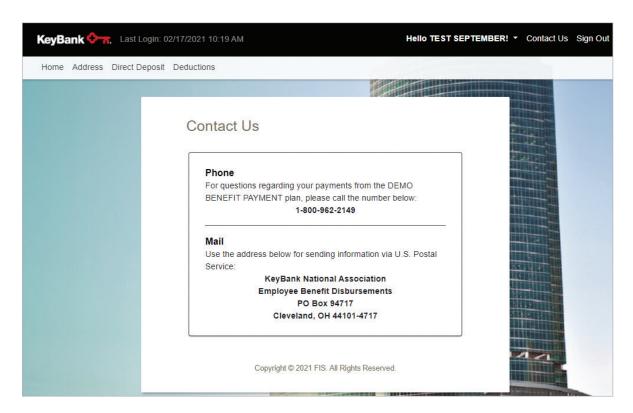
